### **GUIDE TO INFORMATION**

### 1. Introduction

- 1.1 The Freedom of Information (Scotland) Act 2002 requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:
  - Publish the classes of information that they make routinely available;
  - Tell the public how to access the information and whether information is available free of charge or on payment.

The Act also allows for the development of model publication schemes which can be adopted by more than one authority.

### 2. About this Scheme

- 2.1 The Glasgow Colleges' Regional Board adopted the Scottish Information Commissioner's Model Publication Scheme in 2013.
- 2.2 The scheme commits the Glasgow Colleges' Regional Board to:
  - Publishing the information, including environmental information, that it holds and which falls within the classes of information listed in the Model Scheme; and
  - Producing a guide for the public to that information.

### 3. Guide to Information

- 3.1 This guide:
  - Allows the public to see what information is available (and what is not available) in relation to each class of information;
  - States what charges may be applied;
  - Explains how to find the information easily;
  - Provides contact details for enquiries and to get help with accessing information; and
  - Explains how to request information that has not been published.
- 3.2 Availability and formats
  - 3.2.1 The information published through this scheme should, wherever possible, be available on our website <u>www.gcrb.ac.uk</u>. We offer an alternative arrangement for people who do not want to, or cannot, access the information either online or by



inspection at our office. We can, for example, arrange to send out information in paper copy on request (although there may be a charge for this).

- 3.3 Exempt Information
  - 3.3.1 We will publish the information we hold that falls within the classes of information listed. If a document contains information that is exempt under Scotland's freedom of information laws (for example sensitive personal data), we will remove or redact the information before publication and explain why.
- 3.4 Copyright
  - 3.4.1 Where the Glasgow Colleges' Regional Board holds the copyright in the information made available in accordance with this scheme, that information may be copied or reproduced without formal permission, provided that:
    - It is copied or reproduced accurately;
    - It is not used in a misleading context; and
    - The source of the material is identified.

Where the Glasgow Colleges' Regional Board does not hold the copyright in information it publishes, we will make this clear.

3.4.2 In accordance with the Re-use of Public Sector Information Regulations 2015, all GCRB published data is available for re-use under the Open Government Licence: http://www.nationalarchives.gov.uk/doc/open-government-licence/

- 5.4 When providing copies of pre-printed publications, we will charge no more than the cost per copy, pro rata, of the total print run. We do not pass on any other costs to you in relation to our published information.
