#### 1. Report Purpose

**1.1.** Consider the progress reports for the capital projects in 2020-21.

#### 2. Recommendations

- **2.1.** The Committee is invited to:
  - **note** the progress made by the colleges in respect of the capital projects in Financial Year (FY) 2020-21,
  - **note** the small number of variances within the Glasgow Kelvin College budget and **approve** that the college may use these savings for alternative high priority maintenance projects.
  - **note** the significant underspend of Glasgow Clyde College at 28 February 2021 and **approve** the college request to re-allocate:
    - a. an additional £202,000 to the Heating and Ventilation project,
    - b. £57,000 to emerging Health and Safety projects, and
    - c. £454,000 to emerging high priority maintenance projects.
  - **note** the college request (to SFC) to carry forward £1,099,250 of capital funds at the end of FY 2020-21 (i.e. 31 March 2021) and the risks posed.

#### 3. Capital Funds 2020-21

**3.1.** The initial allocation of capital funds for 2020-21 was allocated to the three colleges as follows:

- **3.2.** The initial allocation of lifecycle maintenance costs can be used to meet the cost of estates maintenance. In addition, for 2020-21 the funds can also be used to meet costs relating to IT infrastructure. The wider application of these funds was set out in guidance issued by the Scottish Funding Council.
- **3.3.** Two further allocations of capital funds for 2020-21 were made in August 2020 as follows:

**3.4.** The total capital allocation (to the Glasgow Region) for 2020-21 is £6,998,172 which represents an increase of £3,458,172 compared to 2019-20. The total capital allocation for this financial year is almost double the amount received last year. The allocation of these funds, the applicable criteria and monitoring requirements are set out in the grant letters issued by GCRB to the colleges. Regular progress reports are provided to each meeting of this Committee.

#### 4. City of Glasgow College Update

- **4.1.** City of Glasgow College received £1,620,287 in 2020-21 towards the cost of lifecycle maintenance. This is being used to meet the cost of the NPD unitary charge and to meet maintenance costs not included in the NPD contract.
- **4.2.** In addition, the college received £262,704 to support digital provision. The college has used £155,784 to purchase 457 Chromebooks for use by ESOL students. In addition, a further 306 laptops (costing £106,920) have been purchased to be loaned to students.

### 5. Glasgow Kelvin College Update

# **5.1.** Glasgow Kelvin College implemented its Estates Capital Plan and delivered a range of high priority projects. An update, as at 28 February 2021, is provided below:

- **5.2.** At the end of February 2021, Glasgow Kelvin College had spent 71.5% of the capital budget for the financial year ending 31 March 2021.
- 5.3. There are small number of projects were the forecast expenditure is greater than the original budget. There are also two new priorities that have been identified during the year. The proposed changes are highlighted in the table above. However, the amounts involved are small in comparison with the total expenditure. <u>The Performance and Resources Committee is recommended to approve the changes to the project budgets of Glasgow Kelvin College.</u>
- 5.4. Glasgow Kelvin College also received £713,284 towards the cost of lifecycle maintenance. The lifecycle maintenance grant is critical to ensuring that the College is able to carry out day-to-day planned, and reactive, maintenance in respect of all of its campus buildings. The funding contributes significantly to the totality of non-staff related Estates costs at the College and has been used for replacement equipment, plant maintenance and reactive repairs/replacement.

**5.5.** In addition, the college received £106,213 to support digital provision. This has enabled the College to procure 366 Chromebooks. All of these devices have been distributed to students who met the criteria set by the SFC. Furthermore, 50 MiFi 4G dongles have been distributed to students who require support with internet access.

#### 6. Glasgow Clyde College Update

- **6.1.** Glasgow Clyde College is implementing its Capital Plan, and progressing a range of high priority projects, following the allocation of these funds by GCRB.
- **6.2.** A number of project tenders returned lower costs than were originally planned (particularly the lighting and electrical related works). As a result, the College has asked to re-allocate the balance of these funds to other high priority maintenance projects.
- **6.3.** The three projects for electrical work<sup>1</sup> were merged into a single tender to achieve best value. These are now shown as a single project within the table and are expected to deliver a significant saving compared to the initial budget.
- **6.4.** The external drainage and lightning protection project at the Cardonald campus has now been split into two elements. For the drainage element, CCTV investigations revealed the need for more extensive works than anticipated and these are now planned for 2021-22. The lightning protection element was incorporated within the electrical works tender identified in the previous paragraph.
- **6.5.** Detailed investigations have taken place regarding the heating and ventilation problems at the Anniesland campus. As a result, extensive works have been identified to address a range of long-standing issues. The cost of these works however is significantly higher than the original forecast and the college is seeking to increase the budget to meet the additional cost.
- **6.6.** There have also been delays in starting some projects on site due to Covid-19. This has necessitated additional risk management and consultation with the trade unions. This took time to resolve before works were able to commence. The floorcoverings project has been particularly problematic and has required much discussion with the unions. However, work commenced on site at all three campuses but some elements will be incorporated into the capital plan for 2021-22.
- **6.7.** As a result of savings it is proposed that some additional funding is used to address two additional health and safety improvements. These two projects are fire alarms (in the stairwell refuge areas at the Anniesland campus) and a revised fire evacuation route at the Langside campus. The total estimate of these two projects is £57,000.
- **6.8.** Further emerging high priority projects have also been identified. These projects include the repair of external timber cladding at the Cardonald campus, car park repairs at the Langside and Anniesland campuses and a range of other high priority estates maintenance items. The cost of these new works is estimated to be £454,000.

**6.9.** Finally the project for the Student Space Works at Anniesland which was planned for the use of the Economic Recovery Funds was tendered and an award letter issued in December 2020. Unfortunately, there has been a delay to the start date due to incomplete documentation being in place. This project is due to commence in March 2021 but will now extend into the next financial year and therefore approval must be sought from SFC to carry forward this funding.

- **6.11.** The Performance and Resources Committee is recommended to note the significant underspend of Glasgow Clyde College at 28 February 2021 and approve the request to re-allocate:
  - a. <u>an additional £202,000 to the Heating and Ventilation project,</u>
  - b. £57,000 to emerging Health and Safety projects, and
  - c. <u>£454,000 to emerging high priority maintenance projects.</u>

- 6.12. The information provided by the college at 28 February 2021 shows a significant underspend against the capital budget. At this point, the college is showing expenditure of £96,000 against the approved budget of £2,345,000. It is important to note that the entire budget is due to be spent by the end of the financial year (i.e. 31 March 2021). Therefore, 96% of the budget is unspent with only one month of the financial year remaining.
- 6.13. On 5 March 2021, the college submitted a return to the Scottish Funding Council. Within this return, the college requested that it is permitted to carry forward £1,099,250<sup>2</sup> of capital funds from FY 2020-21 to FY 2021-22. There is a risk that the request is not approved and that the funding has to be returned to the Scottish Funding Council/Scottish Government.
- **6.14.** The Performance and Resources Committee is recommended to **note** the college request (to SFC) to carry forward £1,099,250 of capital funds at the end of FY 2020-21 (i.e. 31 March 2021) and the risks posed.
- **6.15.** Glasgow Clyde College also received £1,141,711 in 2020-21 towards the cost of lifecycle maintenance. The lifecycle maintenance grant is critical to ensuring that the College is able to carry out planned, and reactive, maintenance in all of its campus buildings. The funding contributes significantly to the totality of non-staff related Estates costs at the College. Of this total budget, over £450,000 has been allocated to planned and reactive maintenance and the balance is being used for other essential non-staff premises costs.
- **6.16.** In addition, the college received £205,177 to support digital provision. This is being utilised to partly meet the significant need for digital access to students across the College in the new learning delivery provision. The college is using this funding to procure more than 570 laptops for learners.

#### 7. Risk Analysis

- **7.1.** One of the key risks facing the Glasgow Region is that "Financial sustainability is jeopardised by a reduction in funding and/or an increase in costs." (Risk 008). The provision of additional capital funding helps mitigate this risk.
- **7.2.** The capital plans for Glasgow Clyde College and Glasgow Kelvin College represent a significant investment in 2020-21. There is a risk that the value to be invested is significant but there is limited time available for the projects to be delivered. This risk has materialised within Glasgow Clyde College and has resulted in the request to carry forward these funds to the next financial year.

#### 8. Equalities Implications

**8.1.** The capital grant enables colleges to make improvements, and enhancements, to the facilities for all users.

#### 9. Legal Implications

**9.1.** No legal implications are identified.
