## 1. Executive Summary

**1.1.** The report below provides a review of progress of the college capital projects for the financial year (FY) ending 31 March 2023. The report highlights progress made by the colleges from 1 April 2022.

## 4. Glasgow Clyde College Update

- **4.1.** Glasgow Clyde College has implemented its capital plan for 2022-23, and progressed a range of high priority projects, following the allocation of the funds by GCRB. The plan has been taken forward with Doig and Smith who were appointed for a two-year period for project management and design team services following a tender process.
- **4.2.** The main issue in respect of capital works for the College for 2022-23 has been the evolving situation in respect of the Anniesland campus window repairs project. The College were advised in January of health and safety concerns regarding the windows and had to close the buildings for a period. Some of the buildings were able to reopen after a few weeks however some of the campus had to be closed for over two months. Phase 1 of the works required a survey and remedial works which were completed by Easter 2023. The College has now received estimated costs for phase 2 of the works which are to repair or replace windows as required and this is planned to take place from June 2023 through to Autumn 2023 with the estimated costs before fees and VAT being £984k. This will be the top priority for the College's 2023-24 capital plan.

## 5. Glasgow Kelvin College Update

- **5.1.** Glasgow Kelvin College is implementing its capital plan, and progressing a range of high priority projects, following the allocation of these funds by GCRB.
- **5.2.** The capital plan was slightly amended as the college is awaiting a report in relation to the Springburn external cladding panels. The original budget allocated to this project was not possible to complete prior to 31 March 2023 and other projects were undertaken instead.
- **5.3.** The changes to the project, outlined above, were discussed with the GCRB Finance and Resources Director.

## 6. City of Glasgow College Update

**6.1.** City of Glasgow College received £1,336,088 in 2022-23 towards the cost of lifecycle maintenance. This is being used to meet the cost of the NPD unitary charge and to meet maintenance costs not included in the NPD contract.

- **7.1.** One of the key risks facing the Glasgow Region is that "Financial sustainability is jeopardised by a reduction in funding and/or an increase in costs." (Risk 008). The provision of additional capital funding helps to mitigate this risk.
- **7.2.** The capital plans for Glasgow Clyde College, and Glasgow Kelvin College, represent a significant investment in FY 2022-23. The funds provided are essential in reducing the financial risk and providing the appropriate facilities for learning.
